That he is Secretary of the Seven Falls Owners Association and he knows of his own personal knowledge that the following amendments to the Dedication and Restrictions for Seven Falls Ranch dated September 22, 2000 and recorded in Volume 404, Pages 647 through 666, Real Property Records of Gillespie County, Texas, have been fully adopted in accordance with the provisions of Section 10 of said Dedication and Restrictions.

A majority of two thirds of the Tract Owners present at the annual meeting voted to amend the Bylaws to the following:

Section 6.01. The annual meeting of the Members of the corporation for the election of directors shall be held in January or February of each year once yearly at a location to be determined by the Board of Directors. Special meetings of the Members may be called by the Chairman, the Board of Directors, or by Members having not less than one-third (1/3rd) of the votes of Members entitled to be cast at such meeting.
